INTERIOR

Video Alarm Monitoring

Base Video Alarm Verification Rate: This service covers operator time and actions of a traditional interior security system. This service covers the normal signal alarm allowed for traditional alarm monitoring.

*OHA volume is part of Alarm OHA count

***Requires AI Filtering**

Considerations:

- If sensors are used, the associated cameras must see the sensor's detection area.

- It is assumed that this site type should not send more alarm signals than a traditional Alarm system.

Examples:

Convenience store, liquor store, fast food, small business etc.

EXTERIOR SECURE

Video Alarm Monitoring

This service covers video alarm monitoring of an alarm system with exterior zones within a secure area. A secure area is protected by a perimeter fence or other similar obstruction that keeps unauthorized people out.

*Includes 30 OHEs per month

***Requires AI Filtering**

Considerations:

- Detection of sensor or camera must be inside of fenced area.

- System must have the ability for the end-user to arm & disarm system. (Keypad or Mobile App)

Examples:

Contractor, small distributor, any business surrounded by a fence using outdoor detection.

EXTERIOR UNSECURE

Video Alarm Monitoring

This service covers video alarm monitoring of a system with exterior zones within an un-secure area.

An unsecure area is a location that does not have a perimeter fence or other similar obstruction keeping unauthorized people out of the detection zones. However, this service is designed for locations that are considered restricted and should not have people moving through the property when armed/closed.

*Includes 75 OHEs per month

***Requires AI Filtering**

Considerations:

- System must include Talk-Down Service.

- Dealers should adjust sensor detection when there are excessive TL1 Signals or signals will be filtered.

Examples:

Mid to large unsecured commercial facilities with minimal or no public traffic.

Video Alarm Monitoring

This video service is only for any Bridge with cameras installed inside a protected premise and activated by an alarm system. No AI is required for filtering false alarms. This service covers the normal signal alarm allowed for traditional alarm monitoring.

REMOTE VISUAL GUARD Monitoring

***Requires AI Filtering**

This service is for locations where a security dealer is requesting a video monitoring solution and requires operator time to watch video from multiple cameras on a site. This service is required on accounts with exterior alarm zones in an "un-secure" area and the location is commonly visited by the public. With enhanced video monitoring services, dealers are encouraged to install onsite controls for an operator response during an alarm event. Services like audio talk-down or controlling onsite lights comply with this requirement.

Considerations:

*Includes 150 OHEs per month - System must include Talk-Down Service.

- Dealers should adjust sensor detection when there are excessive TL1 Signals or signals will be filtered.

Examples:

Car lots, campus grounds, public parking areas, parks, new construction, etc.
